CERTIFICATE OF LOCATION OF LORE MINING CLAIM

KNOW ALL MEN by these presents, that the undersigned locator having complied with all of the requirements of law and local rules and customs has claimed and claim by right of discovery and location a lode mining claim in the Unknown Mining District, County of Eureka, State of Nevada, and hereby certify that:

COMMENCING at the Southwest corner which bears S 18° 26' 06" W; 79.06' from the location monument; thence NORTH 150.0 feet to N.W. Corner; thence EAST 1180.0 feet to N.E. Corner; thence SOUTH 150.0 feet to S.E. Corner; thence WEST 1180.0 feet to S.W. Corner, the point of beginning. The S.W. Corner of this lode claim is situated 2983.04 feet in a S 25° 54' 25" E direction from the S.E. Corner, Sec. 4, T.35 N., R.49 E., M.D.B. & M., Eureka County, Nevada.

(d) The undersigned claim is 1180 feet, linear and horizontal measurement, along the course of the vein, together with 75 feet in width on each side of the center of the vein, 25 feet of said lode running WEST from the point of discovery (designated by the location monument).
