Said claim is located upon a valuable mineral deposit containing VANADIUM and other locatable minerals in a vein, lode, or ledge situated in EUREKA County, in the SW 4 of Section 14, Township 14N, Range 52E.

Beginning at the NE Corner No. 1 of this claim; thence S 20° W, a distance of 1500 feet to the SE Corner No. 3; thence W, a distance of 600 feet to the SW Corner No. 4; thence N 20° E, a distance of 1500 feet to the NW Corner No. 6; thence E, a distance of 600 feet to the point of beginning.
