Beginning at the NE Corner No. 1 of this claim; thence S 20 W, a distance of 1500 feet to the SE Corner No. 3; thence W, a distance of 600 feet to the SW Corner No. 4; thence N 20 E, a distance of 1500 feet to the NW Corner No. 6; thence E, a distance of 600 feet to the point of beginning.
