Said claim is located upon a valuable mineral deposit containing VANADIUM and other locatable minerals in a vein, lode, or ledge situated in EUREKA County, in the SE4 of Section 15, Township 16N, 15N Range 51E.

The undersigned claim 1450 feet in a NORTHWESTLY direction and 50 feet in a SOUTHERLY direction along the course of the vein each way from the Discovery Monument upon which is posted the Notice of Location, and 300 feet to each side of the center of the vein, together with all dips, spurs, angles, and variations. The location of each corner monument is given as follows, to wit:

Beginning at the NE Corner No. 1 of this claim; thence S 20° W, a distance of 1500 feet to the SE Corner No. 3; thence W, a distance of 600 feet to the SW Corner No. 4; thence N 10° E, a distance of 1500 feet to the NW Corner No. 6; thence E, a distance of 600 feet to the point of beginning.

TIE: Corner No. 6 of this claim bears

- the SE corner of Section 15, Township 16N, Range 51E or,
- a claim location marker, natural object or permanent monument described as follows: MAP
