AFFIDAVIT OF ANNUAL ASSESSMENT WORK

I, Earl W. Abbott, agent for Trimin Resources Inc., lessee, being first duly sworn, state:

I. That, as required and authorized by 30 U.S.C. Sec. 28, NRS Sec. 517.230 and C.F.R. EXHIBIT "B"

INTRODUCTION

Assessment work on the MH claim block for 1989 consisted of a Geochemical Survey conducted by consultants to Trinin Resources Inc., Dr. Earl W. Abbott of Reno, Nevada and David Rowe of Winnemucca, Nevada, and employees of Geochemical Services Inc. of Reno, Nevada.

WORK PERFORMED

The geochemical work consisted of soil sample collection on a 1200' by 200' grid and analysis for gold and arsenic by a commercial laboratory. The survey was conducted during the period between August 28, 1989 and August 31, 1989.

APPLICABILITY

The work described in this report was performed for and during the assessment year ending September 1, 1989, to be applied to 28 claims owned by N. J. Dircks and leased to Trinin Resources. These claims are more fully described in Exhibit "A".

Dr. Earl W. Abbott is qualified by education and experience to manage geochemical surveys. GEOCHEMICAL FINDINGS

Many of the samples collected were found to be markedly anomalous in gold and/or arsenic. This is consistent with the geochemical signature of disseminated gold orebodies in Nevada.
