INTRODUCTION

Assessment work on the BE claim block for 1989 consisted of a Geochemical Survey managed by a consultant to Trimin Resources Inc., Dr. Earl W. Abbott of Reno, Nevada and conducted by employees of Phoenix Geoscience Inc. of Denver, Colorado.

WORK PERFORMED

The geophysical work consisted of an I.P.-Resistivity Survey, run on 4 lines totalling 23,200 feet. The survey was conducted during the period between August 17, 1989 and August 25, 1989.
