The labor, development and improvements consisted of greater than 80,000 feet of percussion drilling and ore-grade analyses on the recovered sample for the purpose of delineation of minable ore zones. Actual work was done on Aspen claims 5 and 49, Buckaroo 1-8, 361 and 362, Buckhorn 1-9, Humboldt 1 and 2, Lambull 1 and 2, Lone Star, Oro 1 and 2, Sage 103 and 104, and Sunset during the period of September 1st 1988, through August 31, 1989, at a total expenditure in excess of \$500,000.00.

All the aforementioned claims are contiguous, and work on any one claim or group of claims tends to develop all of the claims. The work was performed for the purpose of developing the mineral potential of the claims, and to maintain and hold such claims.
