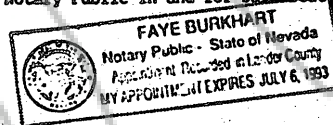

SUMMARY REPORT

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the RED Nos. 955-984, 985-1054, 1105-1144, a group of 110 lode mining claims situated in the Ivanhoe Mining District of Eureka County, Nevada.

The work consisted of geophysical analysis. The work was performed in order to evaluate the property for the presence of valuable mineral deposits located on the subject claims, and to assist in planning further exploration and development work. All geophysical analysis was performed under the direct supervision of Derek Pohle and Robert B. Perry, Geologists for Touchstone Resources. Robert B. Perry has a BS degree in Geological Sciences along with four years experience in geology and civil engineering. Derek Pohle has a BS degree in Geological Engineering and one year of experience as professional geologist.

The basic findings of the study indicate that some geologic factors similar to other known mineralized properties in the region occur within the claim group boundary. The information obtained from geophysical analysis was helpful toward understanding the stratigraphy of the basin and will be used for consideration of future drill targets.
