BOB WALTER MINING, INC., a mining exploration firm, hereby certifies that it has performed annual assessment work for the year ending September 1, 1989 on the unpatented lode mining claims described below.

1. Claim Description. The work was performed for the benefit of the following group of contiguous mining claims situated in Esmeralda County, Nevada:

2. Description, Location and Cost of Work. The work consisted of a geochemical survey performed on the claims group during the period August 16 to August 31, 1989. Brian Resources (U.S.) Inc. collected 27 rock samples at the locations depicted on the map attached hereto as Exhibit "A". The samples were then analyzed for Au, Ag, Bi, Cd, Co, Cr, Cu, Fe, Ga, La, Li, Mn, Mo, Ni, Pb, Sb, Sc, Sn, Sr, Ta, Te, Y, V, Zn and Zr at Bondar-Clegg Inc. at Sparks, Nevada. The total cost of the sampling and assay program was \$1,839.

3. Basic Findings. The geochemical survey disclosed a number of localities anomalous in manganese. A few high zinc values with corresponding high iron content and occasionally high copper values were also obtained. Three high arsenic values were obtained with only one showing any increase in gold content. Chromium values were generally high.


