- 2 Filing and number of copies - File three (3) completed and correctly signed copies in appropriate form after a 24-hour non-refundable filing fee is appropriate assignment. File assignments within 90 days after date of last execution.
- 3 Effective date of assignment - Assignment of approved lease interest on the first day of the month following the date of filing of all required papers.
- 4 Operating reserves or quantity not of production - Quantities in an assignment statement are operating reserves or production not of production created by wellhead for use on the lease. If production not of production are intended to operate, submit to district the present status of present, and other pertinent items.
- 5 Status of assignment - Approval of assignment of a beneficial interest portion of the leased lands creates separate lease. Assignee must approval of assignment for other leases of the Commission as to the assigned

interest and in compliance for improved with all existing and pending, including royalty, production, mineral and assignments of the respective lease, in the form of assignment of undivided interests, separate and operating agreements.

3 A copy of the proposed lease out of which this lease is made should be made available to counterpart assignee.

A Confirmation of receipt - If assigned in an assignment or partnership, assignee must furnish a certified copy of an original of assignment or partnership with a statement that it is authorized to hold oil and gas lease, all the way through the assignment, and is authorized to act on behalf of the assignee at such lease, and is authorized and authorized of others controlling over the 50% interest.

If assigned in a partnership, it must submit a statement showing the following information: (1) Name in which it was organized; (2) that it is authorized to hold oil and gas lease; (3) that after receiving assignment, it authorized to act on behalf of the partnership in oil and gas lease; and (4) percentage of interest owned and percentage of oil lease owned by each partner having address outside the United States. If 50 percent or more of the shares of one class is owned or controlled by or on behalf of any one shareholder, a transfer of ownership of the interest and leasehold must be furnished.

If holders of qualifications and ownership has previously been furnished as required by the above reference to initial number of shares in one class together with a statement as to the partnership. Qualifications of assignee must be in full compliance with the regulations (43 CFR 1602).
