AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., through its Agent and Representative, the undersigned, does hereby make and file this FIRST Amended Location of the WI 107 Lode Mining Claim, on this 29th day of September 1989, and situated in the Unknown Mining District, Eureka County, Nevada.

the point of beginning, and all posts being 3" dia. X 4' long durable plastic pipe.

The locator claims 1500 linear feet along the course of said vein or lode running 230 feet in an east direction and 1270 feet in a west direction from the point of location at which this amended location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is east and west.

To tie this claim to the Public Survey, begin at the Northeast corner Section 23, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north 13,100 feet, and west 7300 feet to the northeast corner of this claim.
