## AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS INC., through its Agent and Representative, the undersigned, does hereby make and file this FIRST Amended Location of the WI 172 Lode Mining Claim, on this 23 day of September 1989, and situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE) (Quarter)Section(s) 10(10), Township 22 North, Range 50 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1:

Thence	750	feet in a	west	direction to post No. 2, marked	WI 172 -2
Thence	750	feet in a	west	direction to post No. 3, marked	WI 172 -3
Thence	600	feet in a	south	direction to post No. 4, marked	WI 172 -4
Thence	750	feet in a	east	direction to post No. 5, marked	WI 172 -5
Thence	750	feet in a	east	direction to post No. 6, marked	WI 172 -6
Thence	600	feet in a	north	direction to post No. 1, marked	WI 172 -1

the point of beginning, and all posts being 3" dia. X 4' long durable plastic pipe.

The locator claims 1500 linear feet along the course of said vein or lode running 1200 feet in an east direction and 300 feet in a west direction from the point of location at which this amended location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is east and west.

To tie this claim to the Public Survey, begin at the Northeast corner Section 23, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north, 8670 feet, and west, 6000 feet to the northeast corner of this claim.

The work of location consisted of making the maps as provided in NRS 517.040. Dated August 4 A.D., 1986, and filed in duplicate.

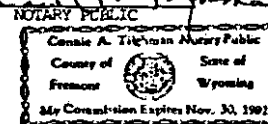
