AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS, INC., through its Agent and Representative, the undersigned, does hereby make and file this SECOND Amended Location of the WI 97 Lode Mining Claim, on this 10th day of September 1989, and situated in the Esmeralda Mining District, Esmeralda County, Nevada.

Said Claim is located in the SW 1/4 (NW 1/4) (Quarter Section 14, 24, 34, 44) Township 23N Range 50E, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1:

Thence	750	feet in a	S 89° 46' E	direction to post No. 6, marked	WI 97	-6
Thence	750	feet in a	S 89° 46' E	direction to post No. 1, marked	WI 97	-1

the point of beginning, and all posts being 3" or 4" wood posts.

The locator claims 1500 linear feet along the course of said vein or lode running 1270 feet in a N 89° 46' W direction and 230 feet in a S 89° 46' E direction from the point of location at which this amended location certificate is posted, with a width of 100 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is N 89° 46' W and S 89° 46' E.

To tie this claim to the Public Survey, begin at the Southeast corner Section 14, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north, 16027 feet, and west, 7090 feet to the northeast corner of this claim.

The work of location consisted of making the maps as provided in NRS 517.040. Dated July 20 A.D., 1987, and filed in duplicate.

And, if the original and first amended Notice of Mining Location is void, then this location shall be an original location and this Certificate an original Certificate.

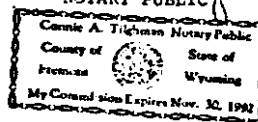
