

AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS, INC., through its Agent and Representative, the undersigned, does hereby make and file this SECOND Amended Location of the WI 109 Lode Mining Claim, on this 29th day of September 1989, and situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW(SE) (Quarter)Section(s) 3(3) Township 22 North, Range 50 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

the point of beginning, and all posts being 3h" or 4" wood posts

The locator claims 1450 linear feet along the course of said vein or lode running 1250 feet in a N 89°46' W direction and 200 feet in a S 89°46' E direction from the point of location at which this amended location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is N 89°46' W and S 89°46' E

To tie this claim to the Public Survey, begin at the Southeast corner Section 14, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north, 12,607.6 feet, and west, 7160.3 feet to the northeast corner of this claim.

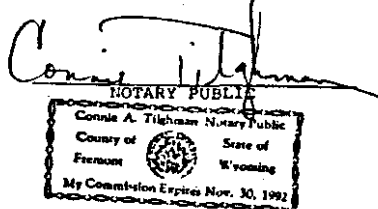
