

AMENDED CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that ATLAS PRECIOUS METALS, INC., through its Agent and Representative, the undersigned, does hereby make and file this SECOND Amended Location of the WI 169 Lode Mining Claim, on this 23rd day of September 1989, and situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW) (Quarter)Section(s) 10(11) Township 22 North, Range 50 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Thence	600	feet in a N 0°24' E	direction to post No. 5, marked WI 169	-5
Thence	750	feet in a S 89°07' E	direction to post No. 6, marked WI 169	-6
Thence	750	feet in a S 89°07' E	direction to post No. 1, marked WI 169	-1

the point of beginning, and all posts being 3 1/2" or 4" wood posts

The locator claims 1500 linear feet along the course of said vein or lode running 10 feet in a S 89°07' E direction and 1490 feet in a N 89°07' W direction from the point of location at which this amended location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The general course of the vein or lode is S 89°07' E and N 89°07' W. To tie this claim to the Public Survey, begin at the Southeast corner Section 14, Township 22 N., Range 50 E., Mt. Diablo P.M., and bear north 9350.2 feet, and west 4361.6 feet to the northeast corner of this claim.
