13 The First and Final Account, Report of Executor, and
14 Petition for Distribution of FIRST INTERSTATE BANK OF NEVADA,
15 N.A., Reno, Nevada, Executor of the Estate of WILLIAM F. COOKE,
16 SR., deceased, came on regularly to be heard this 21st day of
17 April, 1989, BRUCE D. ROBERTS, ESQ., of COOKE, ROBERTS &
18 REESE, LTD., appeared as attorney for petitioner; the Court,
19 after examining the evidence, finds that due notice of such
20 Petition has been given as required by law; that a Notice to
21 Creditors has been given as required by law, that all claims
22 filed against the estate have been paid, with the exception of
23 the Remsa claim filed against the estate; that the final personal
24 federal income tax return for Decedent is being filed; that all
25 other obligations of this estate have been fully paid, except for
26 certain administrative costs and expenses to be paid as herein
27 allowed; that all of the allegations of the Petition are true;
28 that said account should be settled and approved; that more than
three months have elapsed since Letters Testamentary were issued

2 closed and distributed.

3 The Court further finds that the Decedent intended the
4 assets held by petitioner to be distributed in accordance with
5 the provisions of his Last Will and Testament.

6 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

7 1. That the First and Final Account and Report of the
8 Executor be, and the same hereby is, settled, allowed and
9 approved in all respects, and all actions taken by the Executor

12 2. That an attorneys' fee of \$6,500.00 has been agreed upon
13 by the Executor and COOKE, ROBERTS & REESE, LTD., its attorney;
14 that said sum is fair and reasonable and is approved, and the
15 Executor is hereby authorized and directed to pay to COOKE,
16 ROBERTS & REESE, LTD., as and for attorneys' fees for services
17 rendered to the estate the agreed sum of \$6,500.00 and the sum of
18 \$191.80 for costs advanced by said firm.

19 3. That the Executor be, and it hereby is, authorized to
20 pay to itself the sum of \$4,500.37 as its commission as allowed
21 by law.

22 4. Executor is hereby authorized and directed to pay the
23 claim of Remsa in the amount of \$810.44.

24 5. Executor is hereby authorized and directed to pay
25 closing costs and expenses of this estate.

26 6. Executor is hereby authorized to withhold \$5,000.00
27 pending final clearance from the Internal Revenue Service.

28 7. That after the payment of the foregoing fees and costs
