You may within the 15 days pay the specified amount under protest. In that event you will have the right, within 60 days of the date of such payment, to initiate and maintain an action against the Unemployment Compensation Service for recovery of any or all of such amount that was erroneously paid.

These actions are authorized and prescribed in Section 612.630 of Nevada Revised Statutes.

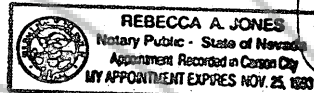
