**NOTICE OF CLAIM OF LIEN**

NOTICE IS HEREBY GIVEN that GILBERT WESTERN CORP., a Delaware corporation with a business address: Suite 250, 5201 Green Street, P.O. Box 57950, Salt Lake City, Utah 84107, hereby claims a lien pursuant to the Nevada Revised Statutes, Chapter 108, in the real property, and all the improvements thereon, hereinafter described for the furnishing of work and materials for the alteration and improvement of said real property, all as more particularly set forth below:

1. The Claimant's demand against said real property, after deducting all just claims and offsets, is ONE MILLION ONE HUNDRED THIRTY-FOUR THOUSAND FOUR HUNDRED FIFTY-SIX DOLLARS AND EIGHTY-ONE CENTS (\$1,134,456.81), no part of which has been paid and all of which is immediately due and owing, and an additional amount estimated to be SIX HUNDRED NINETY-FOUR THOUSAND, FIVE HUNDRED NINETY-FOUR DOLLARS AND NINETY-TWO CENTS (\$694,594.92).
2. The name of the owner or reputed owner is TONKIN SPRINGS GOLD MINING COMPANY, 1600 Stout Street, Suite 1600, Denver, Colorado 80202.
3. Claimant furnished the work and materials to the owners at the special insistence and request of said owners, which materials were incorporated in the work of improvement upon said real property. Claimant furnished work and materials from March 1989 up and until December 5, 1989.
4. Said work and materials were furnished at the express direction and order of the owner with terms and conditions which provided for progress payments to be made, retention, and with final payment to be made upon and after completion of the project.
5. The real property upon which the lien is claimed is located in Eureka County, State of Nevada, and as further described on Exhibit A attached hereto. The property is commonly known as the Tonkin Springs Gold Project.
6. No Notice of Completion has been recorded concerning said work of improvement.
7. Ninety (90) days have not elapsed since Claimant last furnished materials for said work of improvement.


