CERTIFICATION OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned corporation hereby certifies that it has located the RKS 26 lode mining claim in Section 3 and 4, Township 34 North, Range 48 East, Mount Diablo Base and Meridian, in the Unorganized Mining District, County of Eureka, State of Nevada on the 9 day of November, 1989.

The claim is 1500 feet in length and 600 feet in width, and 25 feet is claimed in the West direction and 1475 feet in a East direction from the location monument upon which the Notice of Location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The position of each corner of this claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner and side center monument is as follows:

As erected on the ground, each corner and side line center monument consists of a durable plastic (PVC) pipe at least 3 inches in diameter by 5 feet in length set 1 foot in the ground, and is marked as described above with a tag affixed to the monument post. The monumentations and marking of the above described corners and side line centers on the ground was completed within 60 days from the date of posting and the notice of location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040.
