- 2. Petitioner is the sole heir of Decedent's estate.
- 3. One creditor's claim was filed against the estate. The creditor's claim was filed by T. DAVID HORTON on December 7, 1987, asserting an equitable claim for accounting of mining proceeds and an unliquidated claim for money damages which is now pending in the Seventh Judicial District Court of the State of Nevada, in and for the County of Eureka, Case No. 3129, entitled "Allen Russell and Helen Russell, husband and wife, Plaintiffs, v. T. David Horton, et al., Defendants." The creditor's claim was rejected by the Executrix and the rejection of creditor's claim was filed on January 21, 1988. The matter is currently in litigation.
