- (b) Certain real property located in Crescent Valley Subdivision, Eureka County, Nevada, more specifically described as Lot 8, Block 34, Crescent Valley Ranch and Farms, Unit No. 1;
- (c) One bracelet set with 117 assorted size foil-back rhinestones;
- (d) One lady's necklace with light and dark graduated crystals; and
- (e) The sum of TWENTY THOUSAND DOLLARS (\$20,000.00) in cash.

5. The following unpatented mining claim is distributed to Elmer Schroeder and Ruth Schroeder, husband and wife: One unpatented lode mining claim designated May Lode Mining Claim, situated in the Bullion Mining District, Lander County, Nevada, NMC Number 19753.

6. The Executor is authorized to distribute the following estate monies to the following people or entities:

- (a) Gerald and Sandra Tanner of Salt Lake City, Utah, the cash sum of FIFTY THOUSAND DOLLARS (\$50,000.00);
- (b) St. Mary's Hospital, Reno, Nevada, the cash sum of FIFTY THOUSAND DOLLARS (\$50,000.00); and
- (c) Animal Relief Foundation of Elko County, Nevada, the cash sum of FIVE THOUSAND DOLLARS (\$5,000.00).

7. That the partial distribution of the estate will not cause injury to the creditors of the estate and, after payment of debts as described herein, it appears that, comparatively, the estate is little indebted in view of the remaining liquid or highly liquid assets in the estate. No bond shall be required of the Executor for the partial distribution of the estate.
