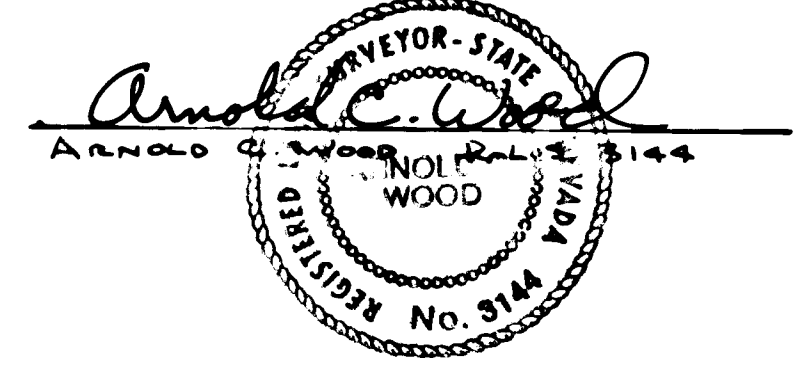


SURVEYOR'S CERTIFICATION

TRACT "A" COMMENCING AT THE SE COR. SECTION 15, T.20N, R.53E M.D.MER.; THENCE N. 89°59'41" W. ALONG THE SOUTH BOUNDARY OF SAID SECTION 15, 2639.01 FEET TO THE 1/4 CORNER OF SAID SECTION 15, THE TRUE POINT OF BEGINNING; THENCE CONTINUING ALONG SAID SOUTH BOUNDARY OF SECTION 15, N. 89°59'41" W., 1338.01 FEET TO THE CORNER OF SECTION 21, T.20N, R.53E, M.D.MER.; THENCE N. 0°16'12" W. ALONG THE EAST SECTION LINE OF SAID SECTION 21, 292.12 FEET TO THE NORTHEAST CORNER OF SAID SECTION 21; THENCE N. 0°01'00" W., 23.00 FEET; THENCE S. 79°47'08" E., 1360.71 FEET TO A POINT ON THE CENTER 1/6 LINE OF SECTION 15, T.20N, R.53E, M.D.MER.; THENCE S. 0°00'47" E. ALONG THE SAID CENTER 1/6 LINE OF SECTION 15, 24.00 FEET TO THE TRUE POINT OF BEGINNING. CONTAINING 193,485.86 SQUARE FEET OR 4.4418 ACRES MORE OR LESS OF THE SW 1/4 SECTION 15, T.20N, R.53E, M.D.MER. EUREKA CO., NEVADA.

ALONG THE CENTER 1/6 LINE 251.00 FEET TO THE SOUTH 1/4 CORNER OF SAID SECTION 10; THENCE N. 89°50'00" W. ALONG THE SOUTH BOUNDARY LINE OF SAID SECTION 10, 2639.66 FEET TO THE TRUE POINT OF BEGINNING. CONTAINING 66,551.27 SQUARE FEET OR 15.2101 ACRES OF THE SW 1/4 SECTION 10, T.20N, R.53E, M.D.MER. EUREKA COUNTY, NEVADA.
