To Whom It May Concern:

This letter reiterates the statements made in my letters of 4 August, 1989, which are:

1) I, Joseph F. Leising, was granted a 6% interest in all mineral properties found by me and acquired by Consol Nevada Corporation. This was done at a Consol Nevada Board of Directors meeting on 4 April, 1983, as part of my compensation as a Consol Nevada employee.

2) Accordingly, it is my wish and instruction that, in the event your organization exchanges remuneration, stock shares, or other consideration with Consol Nevada, 6% of that consideration be given to me, directly, here in Reno.

I have received no such consideration from your organization, so I repeat that request. Further, I hereby serve notice that 6% of any consideration whatever that your organization receives, whether remuneration, stock, land, options, or some other form, from any individual, partnership, corporation, or other entity, whether by sale, lease, exchange, or other means, be paid to me, here in Reno; and that I be granted such full rights as the law allows to influence and approve any sale, lease, exchange, or other disposition, including abandonment and/or relocation.

My request covers the following claimblocks, with such areas of influence as were agreed upon in the Alhambra/Consol Nevada contract:
