The exterior boundaries of this claim are clearly marked by substantial 3-inch diameter x 5 foot long plastic post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:

thence N. 87° 00' 00" E., 750 feet to the North Side Center (Cor. No. 2).

thence N. 87° 00' 00" E., 750 feet to the Northeast Corner (Cor. No. 3).

thence S. 87° 00' 00" W., 750 feet to the South Side Center (Cor. No. 5).

thence N. 03° 00' 00" W., 600 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.

The monumentation and marking of the corners was completed by the 24th day of November, 1989.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
