CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

THIS IS TO CERTIFY that the JD No. 19 lode mining claim was located by:

Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,300 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Westerly and Easterly with 1,490 feet claimed in a Westerly direction and 10 feet in an Easterly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Eureka, State of Nevada and is located in all or in part of the following 1/4 Section(s):

- SE 1/4 of Section 10, Township 25 N., Range 49 E., M.D.B. & M.
- NW 1/4 of Section 11, Township 25 N., Range 49 E., M.D.B. & M.
- SW 1/4 of Section 11, Township 25 N., Range 49 E., M.D.B. & M.
- 1/4 of Section , Township 25 N., Range 49 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 2, Township 25 N., Range 49 E., Mount Diablo Base and Meridian, thence South, approximately 2,698 feet and West, approximately 1,080 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial 3-inch diameter x 5 foot long plastic post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence N. 87°00'00"E., 750 feet to the North Side Center (Cor. No. 2),

thence N. 87°00'00"E., 750 feet to the Northeast Corner (Cor. No. 3),

thence S. 03°00'00"E., 600 feet to the Southeast Corner (Cor. No. 4),

thence S. 87°00'00"W., 750 feet to the South Side Center (Cor. No. 5),

thence S. 87°00'00"W., 750 feet to the Southwest Corner (Cor. No. 6),

thence N. 03°00'00"W., 600 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.

The monumentation and marking of the corners was completed by the 24th day of November, 1989.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
