The general course of the lode deposit and premises is from the N/W to the S/E.



- Corner No. 5 is a PCV POST MARKED W CENT HASH # 24
- Corner No. 6 is a PCV POST MARKED N/W COR HASH # 24

The monumentation and marking of the corners was completed by the 14 day of JAN, 1990.
