

CERTIFICATE OF LOCATION - LODGE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

ECM, Inc., by and through its lawful and authorized agent, Keith K. Kolstad, gives notice that it claims the land described below as a lodge mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing its rights, states and certifies as follows:

1. The name of the claim is Rose 5750.
2. The name and current mailing address of the locator is ECM, Inc., 2720 3rd Ave. North, Suite 450, Billings, MT 59101.
3. The date of location is January 9, 1990.
4. The claim is 1450 feet long and 550 feet wide, such that 1400 feet is claimed in a SW direction and 50 feet in a NE direction from the location monument, on which the Location Notice is posted, lengthwise of the claim, together with 275 feet in width on each side of the location monument and centerline of the claim. The general course of the lode or vein is SW at N45° E as nearly as may be determined.
5. The location work consisted of making maps as provided by NRS 517.040.


