AMENDED
CERTIFICATE OF LOCATION
(NEVADA - LODE)

The undersigned, WESTMONT GOLD INC., whose address is 4949 South Syracuse Street, Suite 4200, Denver, Colorado 80237, hereby certifies that it has amended the Discovery #1 Lode mining claim as more particularly described below. The original date of location is the 8th day of September, 1989. The date of this Amended Certificate is the 8th day of December, 1989. The original certificate of location is recorded in the official records of Eureka County, Nevada, at Book 205, Page 458, and filed with the Bureau of Land Management under Serial No. N MC 574084.

Said claim is located in the Lynn Mining District, Eureka County, Nevada, in the following location:

NE/4 of Section 11, Township 35 NORTH, Range 50 EAST, M.D.R. + M.
NW/4 of Section 11, Township 35 NORTH, Range 50 EAST, M.D.R. + M.
SW/4 of Section 11, Township 35 NORTH, Range 50 EAST, M.D.R. + M.

To tie this claim to the Public Survey, begin at the Northwest corner of Section 11, Township 35 North, Range 50 East, M.D.R. + M., Mount Diablo Meridian, thence 4180 feet South and 4028 feet EAST to the northeast corner of this claim.

I claim 1500 linear feet along the course of the ledge, lode or vein, extending 550 feet from the location monument in a westerly direction and 950 feet in a easterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial monuments firmly set in the ground and bearing applicable 4" P.V.C. monuments set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, West	750	feet to the North	side center,
thence, West	750	feet to the Northwest corner,	
thence, South	600	feet to the Southwest corner,	
thence, East	750	feet to the South	side center,
thence, East	750	feet to the Southeast corner,	
thence, North	600	feet to the Northeast corner,	
point and place of beginning.			

The monumentation and marking of the corners was completed by the 2nd day of February, 1990.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.

The locator hereby confirms that it is the locator's intent to abandon those portions of the Yellow Rose 8, N MC 1182; Yellow Rose 9, N MC 1183; and Yellow Rose 10, N MC 1184 to the extent and only to the extent that these claims are in conflict with this amended location.
