

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

ledge, lode or vein, extending 1,480 feet from the location monument in an East-
terly direction and 10 feet in a Westerly direction, together with 295
feet on each side of the center of the ledge for the entire length of the claim.
