We (or I) claim 1,490 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,480 feet from the location monument in a westerly direction and 10 feet in an Easterly direction, together with 295 feet on each side of the center of the ledge for the entire length of the claim.
