

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

<u>NE</u> 1/4 of Section <u>22</u> , Township <u>25</u> N., Range <u>49</u> E., M.D.B. & M.
<u>NW</u> 1/4 of Section <u>23</u> , Township <u>25</u> N., Range <u>49</u> E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Southwest corner of Section 28, Township 25 North, Range 49 East, Mount Diablo Base and Meridian, thence North, approximately 10,935 feet and East, approximately 9,916 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,490 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,480 feet from the location monument in an East-Westly direction and 10 feet in a Westerly direction, together with 295 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest corner (Corner No. 1),

thence, <u>N.90°00'E.</u> , <u>745</u> feet to the <u>North Side</u> Center (Cor. No. 2),
thence, <u>N.90°00'E.</u> , <u>745</u> feet to the <u>Northeast</u> Corner (Cor. No. 3),
thence, <u>S.00°00'E.</u> , <u>590</u> feet to the <u>Southeast</u> Corner (Cor. No. 4),
thence, <u>S.90°00'W.</u> , <u>745</u> feet to the <u>South Side</u> Center (Cor. No. 5),
thence, <u>S.90°00'W.</u> , <u>745</u> feet to the <u>Southwest</u> Corner (Cor. No. 6),
thence, <u>N.00°00'W.</u> , <u>590</u> feet to the <u>Northwest</u> Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 19th day of January, 1990.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
