

CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

THIS IS TO CERTIFY that the SIM No. 243 lode mining claim was located by:

To tie this claim to the Public Survey, begin at the Southwest Corner of Section 28, Township 25 North, Range 49 East, Mount Diablo Base and Meridian, thence North, approximately 5,625 feet and East, approximately 15,876 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,180 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,170 feet from the location monument in a South-erly direction and 10 feet in a Northerly direction, together with 200 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch diameter x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

- Beginning at the Northwest Corner (Corner No. 1),
- thence, N.90°00'E., 400 feet to the Northeast Corner (Cor. No. 2),
- thence, S.00°00'E., 590 feet to the East Side Center (Cor. No. 3),
- thence, S.00°00'E., 590 feet to the Southeast Corner (Cor. No. 4),
- thence, S.90°00'W., 400 feet to the Southwest Corner (Cor. No. 5),
- thence, N.00°00'W., 590 feet to the West Side Center (Cor. No. 6),
- thence, N.00°00'W., 590 feet to the Northwest Corner (Cor. No. 1),
- the point and place of beginning.

The monumentation and marking of the corners was completed by the 19th day of January, 1990.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
