

AMENDED NOTICE AND CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that Debenham Electric Supply Company, Inc., claims a Mechanic's and Materialman's Lien in the amount of \$19,862.61 upon that certain real property located in the county of Eureka, State of Nevada, commonly known as the Tonkin Springs Gold Mine and more particularly described in paragraph 6 (the "Property") of this Notice and Claim of Lien. This claim is made pursuant to the laws of the State of Nevada, particularly Chapter 108 of the Nevada Revised Statutes, as amended, for the value of electrical materials and equipment furnished by Lien Claimant for the improvement of the Property.

Claimant further states:

1. The name of the owner or reputed owner of the Property is the Tonkin Springs Gold Mining Co. and/or U.S. Gold Corporation.

2. The name of the person by whom Lien Claimant was employed and to whom Lien Claimant furnished the Work is Tonkin Springs Gold Mining Co.

3. The terms, time given and conditions of the contract were that the Lien Claimant would furnish the material and equipment on project account which was to be paid monthly. Amounts not paid monthly are subject to finance charges of 1½% per month.

4. Lien Claimant furnished the first of the material and equipment on or about August 21, 1989 and furnished the last of the material and equipment on or about December 8, 1989.

5. Lien Claimant's material and equipment was furnished to and actually used upon the property in the unpaid total amount of \$19,862.61; after all just credits and payments, there remains due and owing to Lien Claimant the sum of \$19,862.61 for the material and equipment.

6. The description of the Property to be charged is that property appurtenant to and upon which the Tonkin Springs Gold Mine is operated and is located approximately 60 miles south of Carlin, Nevada on SR278. The property is more particularly described as the Tonkin Springs Gold Mine, Eureka County, Nevada, located on portions of Sections 1 and 2, Township 23½ North, Range 49 East, Mount Diablo Base & Meridian, including, but not limited to, Tonkin Mill Site Claims Nos. 1 through 74, 87 and 88 and all other mining and mineral rights associated therewith; also including Tonkin Mill Site Claims Nos. 75 through 86 located on portions of Section 36, Township 24 North, Range 49 East, Mount Diablo Base & Meridian; also including Rooster Mill Site Claims Nos. 1 through 6 located on portions of Section 28, Township 24 North, Range 49 East, Mount Diablo Base & Meridian;

and also including Rooster Mill Site Claims 7 through 26 located on portions of Section 27, Township 24 North, Range 49 East Mount Diablo Base & Meridian.

7. Demand for payment of the remaining amounts due and owing was made by Lien Claimant, and no part or portion of the amount due and owing has been paid; there are no further offsets to the claim; and the sum of \$19,862.61 plus interest at the contract or the highest legal rate is now due and owing to Lien Claimant on account of the furnishing of material and equipment. Lien Claimant claims a lien upon the property for \$19,862.61, plus interest, costs and attorneys fees as provided by law.

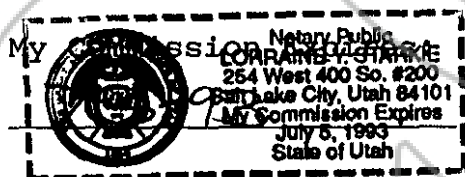
