

covered health insurance provided from respondent's employment
and which is commonly referred to as Aetna government-wide health
insurance.

The Court also orders respondent to pay petitioner's
attorney fees and costs in the sum of \$364.50.

Petitioner and respondent recognize that the above division
of community property may not be exactly equal, but each waives
equal distribution and recognizes that the above represents a
fair and equitable division of the community assets and oblig-
ations of the parties.

Petitioner and respondent recognize the jurisdiction of
this Court to enter a Stipulated Interlocutory Judgment, and
each waives findings of fact and conclusions of law, and right to
appeal.

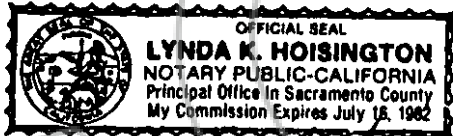
