NOTICE OF LIEN CLAIM

NOTICE IS HEREBY GIVEN:

1. That Serrot Corporation, hereby claims a mechanic's lien pursuant to the provisions of NRS 108.221, et seq., laws of the State of Nevada, in the amount of \$79,037.76 on the real property and improvements located on a portion of Sect 1,4,5,6,23,32,34,27,28 Township 23 and 23 1/2, 24 North, Range 49 East, as shown by a map thereof on file in the Office of the Recorder, Eureka County, Nevada, more commonly known as U. S. Gold, Tonkin Springs, Nevada.

2. The owner or reputed owner of the above described property is Silver State Mining Corp., Tonkin Spring Gold Mining Company, U.S. Gold, whose address is 1325 Airmotive Way, Reno, Nevada.

3. This lien is claimed for materials and labor for lining ponds with High Density Polyethylene and modifying solution collection trench, at the above address.

7. That the claimant herein is entitled to a reasonable attorney's fee, statutory interest on the amount of this lien claim and costs incurred in perfecting this lien claim.
