## NOTICE OF ABANDONMENT OF UNPATENTED MINING CLAIMS

THIS NOTICE OF ABANDONMENT is made effective as of the 9th day of January, 1990 as to Rat claims #17, 19 and 32, and effective as of the 10th day of January 1990 as to Rat claim #18, by MARY M. BISONI, whose address for purposes hereof is P.O. Box 152, Eureka, Nevada 89316, and GENEVE BISONI, whose address for the purposes hereof is 2475-7 Sycamore Glen Drive, Sparks, Nevada 89434 (hereinafter the "Bisonis").

## RECITALS

A. The Bisonis are the owners of certain unpatented lode mining claims situated in Eureka County, Nevada, Township 18 North, Range 53 East, more particularly described as follows:

- B. The Bisonis and Amselco Minerals Inc. (hereinafter "Amselco") entered into that certain Agreement, dated April 15, 1979, a memorandum of which is recorded in the official records of the Eureka County Recorder in Book 70, Page 543, pursuant to which Amselco agreed to manage and maintain the Claims, among other claims.
- C. Amselco Exploration Inc., Amselco's wholly-owned subsidiary, occasionally undertook to manage and maintain the Claims, and on March 10, 1986 and May 1, 1986, Amselco Exploration Inc. mistakenly relocated the Claims in its own name, rather than as agent for the Bisonis. Those relocated claims are more particularly described as follows:

D. Assessment work has been performed on the Claims, rather than on the Relocated Claims, from 1986 through 1989 and the Bisonis fear that neither the Claims nor the Relocated Claims are now valid. For that reason, on or about January 10, 1990,

the Bisonis located new unpatented lode mining claims, also named Rat Nos. 17-19, 32, which claims may include portions of the ground covered by the Claims.

E. The Bisonis wish to confirm by this Notice of Abandonment that the Bisonis intend to and do hereby abandon and assert no right, title or interest in or to the Claims or the Relocated Claims.

NOW, THEREFORE, the Bisonis intend to and hereby do abandon all of their right, title and interest in and to the Claims and the Relocated Claims and request a decision by the BLM that neither the Claims nor the Relocated Claims are valid.
