




NOTICE OF NON-RESPONSIBILITY

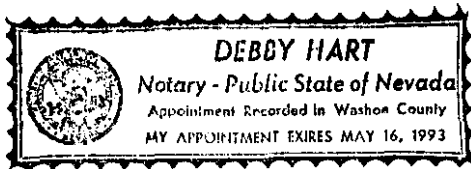
