

DECLARATION OF HOMESTEAD



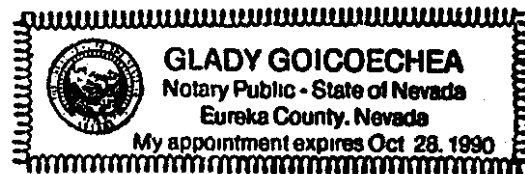
