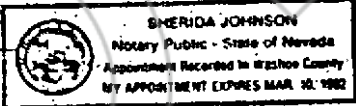

SUMMARY REPORT
April 30, 1990


This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the DV 101 through 119, the DV 500 through 520; and the NW 201 through 231 claims, a contiguous group of 71 lode mining claims situated in the Huntington Mining District, White Pine and Eureka Counties, Nevada.

The work consisted of geochemical soil sampling of the claim group, to evaluate the discovery of valuable mineral deposits located thereon and to assist in planning further exploration and development work. The work was performed between September 27 and October 4, 1989, and between January 15 and 22, 1990, by Ann M. Kramer, a geologist with a Master's Degree in Economic Geology from Colorado School of Mines (1984) and nine years experience in exploration-economic geology; and by Anthony Doctor, a geologist with a Bachelor's Degree (1989) from Western State College, Gunnison, Colorado. The cost of the geochemical survey exceeded \$8,000, and was paid by Tenneco Minerals Company, which leases the claims from Cave Valley Mining Company of Elko, Nevada. Cone Geochemical of Denver, Colorado performed the geochemical analyses.

The basic findings of this survey indicate that geologic factors similar to other known mineralized properties in central Nevada occur within the boundaries of the claim group. An exploration program consisting of drilling, mapping, sampling, and geophysical studies is under consideration for this property.

Over 260 soil samples were analyzed for gold. Several gold anomalies were identified by this soil survey.

Detailed maps, sample locations and descriptions, and geochemical results of this survey are in the possession of and are considered the exclusive property of Tenneco Minerals Company, owner of the subject mining claims, with offices at 5301 Longley Lane, #113, Reno, Nevada 89511, Attention: Ann M. Kramer, Geologist.
