

SPECIAL WARRANTY DEED

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, ECHO BAY EXPLORATION, INC., a Delaware corporation and THE 25 RANCH VENTURE, a venture consisting of Western States Minerals Corporation, a Utah corporation, and Echo Bay Exploration Inc., as all of its venturers ("Grantor"), whose address is 370 Seventeenth Street, Suite 4050, Denver, Colorado 80202, hereby grants, bargains, sells, conveys, transfers, assigns and delivers to WESTERN STATES MINERALS CORPORATION, ("Grantee"), whose address is 4975 Van Gordon Street, Wheat Ridge, Colorado 80033, the fee lands and unpatented mining claims more particularly described in Exhibit A attached hereto and incorporated by reference herein.

TOGETHER WITH all and singular the rights, privileges, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and together with all lodes, ledges, veins and mineral bearing rock, both known and unknown, lying within the boundaries of the above named claims, together with all dips, spurs, and angles, and all the ores, mineral-bearing quartz, rock and earth or other deposits therein or thereon, and all of the rights, privileges and franchises thereto incident, and all and singular the tenements and hereditaments thereunto or in anywise appertaining, and the rents, issues and profits thereof; and also all the estate, right title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of said Grantor, of, in or to the premises and every part and parcel thereof, including all after acquired title.

EXCEPTING AND RESERVING TO THE GRANTOR, its successors and assigns, all metals, ores, and minerals of every kind and character whatsoever, precious and base, metallic and non-metallic, which are or may hereafter be found or situate in, on, or under those lands described in Exhibit B hereto (the "Rock Creek Properties"), including, but in no way limited to, gold, silver, barite, coal, oil, gas, associated hydrocarbon substances, and geothermal resources;

FURTHER EXCEPTING AND RESERVING TO GRANTOR, its successors and assigns, the sole and exclusive right and privilege to do any and all things which Grantor shall deem necessary or desirable to explore for, develop, mine, treat, ship, and otherwise exploit and dispose of any and all of said metals, ores and minerals found or situate in, on or under the Rock Creek Properties, including, without limitation, the sole and exclusive right and privilege of ingress and egress to and from the Rock Creek Properties for purposes of surveying, exploring and prospecting for, sampling, drilling, developing, mining (whether by underground, strip, open pit, solution mining or any other methods or combination of methods), stockpiling, removing, shipping, transporting, processing, marketing or

otherwise disposing of any such metals, ores or minerals or mineral-bearing ores and materials mined, extracted or removed either from the Rock Creek Properties or from other lands; to construct, use, maintain, repair, replace and relocate on the Rock Creek Properties such buildings, roads, tunnels, railroad corridors or loadout facilities, ore conveyors, tailing ponds, waste dumps, ditches, pipelines, power and communication lines, structures, mills, processing facilities, utilities and other improvements and facilities as may be reasonably required by the Grantor for the full enjoyment and exploitation of such metals, ores or minerals derived from the Rock Creek Properties or from other lands; to use so much of the Rock Creek Properties and the surface and subsurface thereof as may be reasonably necessary, convenient or suitable for any mining purpose whatsoever, including, without limitation, the transportation, haulage, storage, stockpiling, and permanent disposal of ore, broken rock, mine or other wastes, residues, tailings or other by-products of development, production or other operations; to use, destroy, or cave so much of the surface and subsurface of the Rock Creek Properties as may be reasonably necessary, convenient, suitable for or incidental to any of the rights and privileges of Grantor hereunder; to appropriate and use, consistent with applicable laws of the State of Nevada, any surface and underground water now existing or subsequently discovered or developed in connection with the development and enjoyment of such metals, ores or minerals or for use on other lands by the Grantor, its successors and assigns; to mine, remove and transport such metals, ores or minerals, either underground or on the surface, from or through the Rock Creek Properties to or through other lands in the vicinity of the Rock Creek Properties which are owned, leased or operated by Grantor, its successors and assigns, and to mine, remove and transport such metals, ores or minerals mined or extracted and removed from such other lands across or through the Rock Creek Properties; and to exercise all other rights which are incidental to any or all of the rights specified, mentioned, or referred to herein.

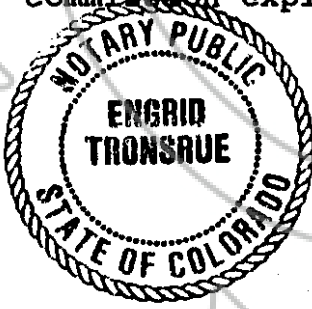

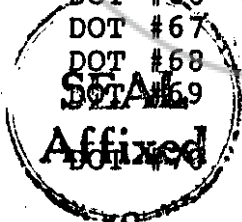
