## MEMORANDUM OF MINERAL LEASE

This MEMORANDUM OF MINERAL LEASE effective this 6 day of May, 1990, is filed of record in accordance with the provisions contained in a MINERAL LEASE (the "Agreement") of even date herewith, wherein CAROL R. DAVIS and JERRY A. DAVIS, whose address is 1263 Mountain View, Elko, Nevada 89801 (the "Lessor") has granted and hereby grants to REYNOLDS METALS EXPLORATION, INC., a Delaware corporation authorized to transact business in Nevada, with an office address at 6601 West Broad Street, Richmond, Virginia 23230 (the "Lessee") an exclusive lease of unpatented mining claims and any fixtures or improvements thereon (the "Property") located in Eureka County, Nevada, the Property being identified on Exhibit A (attached hereto and made a part The Property is leased by Lessor to Lessee for the consideration and subject to all of the terms and conditions contained in the Agreement, which terms and conditions include, but are not limited, to the following:

- 1. GRANT OF RIGHTS. Lessor granted and hereby grants to Lessee an exclusive lease of the Property, including all ores, metals, minerals, tailings, concentrates and mineral products (the "Minerals") and all water rights appurtenant to the Property, together with the exclusive right to enter upon, possess, and use the Property for exploration, development, mining, extraction, processing and marketing of all Minerals and for all such other purposes related to such operations on other properties adjacent to or in the vicinity of the Property, subject only to a production royalty reservation in Lessor, and subject to the paramount title of the United States.
- 2. TERM. The Agreement is granted for an initial term of 20 years and so long thereafter as Lessee is exercising the rights granted in the Agreement and continues to make the minimum advance royalty payments (the "Minimum Payments") set forth in the Agreement.

## 3. MINIMUM PAYMENTS AND PRODUCTION ROYALTY PAYMENTS.

A. In lieu of any obligation on the part of Lessee to explore, develop or mine the Property or perform any other activities thereon, Lessee shall pay to Lessor Minimum Payments in the amounts set forth in the Agreement.

- B. Under the terms of the Agreement, Lessor shall receive a Production Royalty on the Minerals mined from the Property and sold by Lessee from any portion of the Property.
- 4. ASSIGNMENT. All of the terms and conditions of the Agreement shall be binding upon and inure to the benefit of the parties and their heirs, successors, and assigns.
