The location work consisted of making the maps provided in NRS 517.040. Dated July 3 A.D., 1990, and filed in duplicate.

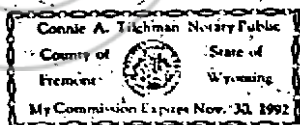
