

ASSIGNMENT OF OVERRIDING ROYALTY INTERESTS

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, R. BRUCE TRIMBLE, of 1656 South Holland Court, Lakewood, Colorado 80226, (hereinafter referred to as "Assignor") is the owner and holder of sufficient interests in the Oil and Gas Leases described on Exhibit "A", attached hereto and made a part hereof, covering lands in White Pine, Nye, and Eschscholt Counties, Nevada.

of all oil, gas and other liquid or gaseous hydrocarbon substances produced, saved and sold under the terms of the aforesaid oil and gas leases, same to be delivered to the pipeline free and clear of all costs of development or operations, save and except gross production or like taxes chargeable thereto.

IN THE EVENT Assignor's oil and gas leases herein described cover less than all the oil and gas mineral rights in and to said lands covered thereby, the overriding royalty interests herein assigned shall be proportionately reduced so as to be equal to that portion of said overriding royalty on said production which the interest in said leases bears to the full and undivided oil and gas mineral estates in said lands.

TO HAVE AND TO HOLD, the terms and conditions hereof shall apply to any extensions and renewals of the aforesaid oil and gas leases, and shall be binding on the Assignor and Assignee and their respective successors, heirs, personal representatives, devisees, and assigns forever.
