

CERTIFICATE OF LOCATION - LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

Independence Mining Company Inc., a Delaware corporation, by and through its lawful and authorized agent, Corinne J. Antone, gives notice that it claims the land described below as a lode mining claim pursuant to the laws of the United States of America and the State of Nevada, and in making such claim and establishing its rights, states and certifies as follows:

1. That the locator is a corporation lawfully organized and existing under the laws of the State of Delaware, United States of America.

2. The name of the claim is PH No. 4.

3. The name and current mailing address of the locator is Independence Mining Company Inc., P.O. Box 41330, Reno, Nevada 89504.

4. The date of location is May 2, 1990.

5. The claim is 1,500 feet long and 600 feet wide, such that 1,480 feet is claimed in an easterly direction and 20 feet in a westerly direction from the discovery monument, on which the Location Notice is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode or vein is east and west as nearly as may be determined.

6. The location work consisted of making maps as provided by NRS 517.040.

7. The number, location and markings on each boundary or corner monument is as follows:

The definition of the boundaries of the claim, together with the erection and marking of boundary and corner monuments, was completed by the 28th day of June, 1990.

8. Corner No. 1 (the NW corner) of this claim is situated approximately 5,840 feet east and 5,600 feet south from the northwest corner of Section 6, Township 23 North, Range 50 East, MDB&M.
