NOTICE OF CLAIM OF LIEN

Notice is hereby given that Powertech, Inc., an Oregon corporation, claims a lien upon the real property and improvements described below pursuant to NRS 108.222 for the value of materials and labor furnished, which were to be used, and which were actually used, in the improvements on real property known as the Tonkin Springs Gold Project, located sixty (60) miles south of Carlin, Nevada on State Route 278. The legal description of said real property is believed to be:

Township Twenty-Three and one-half
North, Range Forty-Nine East, Section Two.

Tonkin Springs Gold Mining Company (Tonkin Springs) engages in mining operations at the above described location. Tonkin Springs is closely associated with, and believed to be wholly owned by, U.S. Gold, whose offices are located at 1600 Stout Street, Suite 1600, Denver, Colorado 80202.

Tonkin Springs and U.S. Gold entered into a contract with claimant under which claimant agreed to, and has furnished equipment for the handling of raw materials, specifically, fabricated steel components to be installed in a bio-oxidation plant. Said components are actually used in and about the described premises.

The contract, as evidenced by shipping invoices, required Tonkin Springs and U.S. Gold to pay claimant \$27,145.00. The owners of said property have paid \$12,096.53 and said amount is

duly credited to the owner's account. There remains presently due and owing to claimant \$15,048.47 for materials and labor, and, as yet undetermined amount of interest at the statutory rate, cost for the preparation of this lien, and costs for recording and serving upon the property owners this lien.

The owners had due notice of the material and labor being furnished to the property sought to be charged by this lien. The claimant has made demand for the payment of the amount due and owing for the materials and labor supplied.

The installation of the materials furnished by claimant was completed in late December, 1989. On information and belief, no valid Notice of Completion pursuant to NRS 108.228 has been filed with respect to the property that is the subject of this Notice of Claim of Lien. Therefore this lien claimant, Powertech, Inc., claims the benefits of the laws relating to the liens and mechanic liens upon property known as the Tonkin Springs Gold Project, located sixty (60) miles south of Carlin, Nevada on state Route 278, along with buildings and other improvements thereon, and for attorney fees and costs of preparing, recording and enforcing this claim of lien, together with interest to accrue.
