Bond Number 107226 dated June 8, 1990, issued by American Bonding Company as

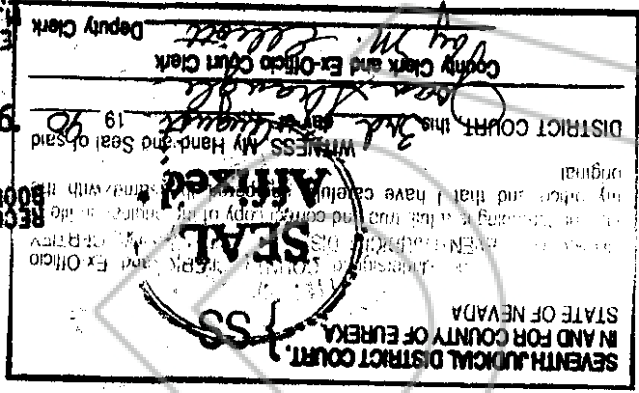
