(f) The location monument, each corner and side center, is in each instance, represented by a post at least 3 inches in diameter by 4 feet in length and set 1 foot in the ground and or rock cairn; the respective corner post being marked as follows: "S.E. Corner AFBN No. 55", "S.W. Corner AFBN No. 55", "N.W. Corner AFBN No. 55", and "N.E. Corner AFBN No. 55".
