(f) The location monument, each corner and side center, is in each instance, represented by a post at least 3 inches in diameter by 4 feet in length and set 1 foot in the ground and or rock cairn; the respective corner post being marked as follows: "S.R. Corner AFBN No. 57", "S.W. Corner AFBN No. 57", "N.W. Corner AFBN No. 57", and "N.E. Corner AFBN No. 57".

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused location work to be performed upon said mining claim consisting of maps as provided in NRS 617.040.

(d) The undersigned claim is 1500 feet, linear and horizontal measurement, along the course of the vein, together with 300 feet in width each side of the center of the vein, 1490 feet of said lode running west from the point of discovery (designated by the location monument).
