

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN by these presents, that the undersigned locator having complied with all of the requirements of the law and local rules and customs has claimed and claim by right of discovery and location a lode mining claim in the Unknown Mining District, County of Eureka, State of Nevada, and hereby certify that:

(a) The name of said lode or vein and lode mining claim is: AFBN # 58

(c) Said mining claim was located on 6/22/90, is in Section 20, T. 33 N., R. 50 E., M.D.B. & M., and is bounded and described as follows:

COMMENCING at the southwest corner which is 10 feet west and 300 feet south of the location monument; thence North 600 feet to the N. W. corner; thence east 1500 feet to the N.E. corner; thence South 600 feet to the S.E. corner; thence west 1500 feet to the S. W. corner, at the point of beginning. The S.W. corner of this lode claim is situated 1500 feet in a WEST direction and 4800 feet in a NORTH direction from the S.E. corner, and 20, T. 33 N., R. 50 E., M. D. B. & M., EUREKA County, Nevada.

(d) The undersigned claim is 1500 feet, linear and horizontal measurement, along the course of the vein, together with 300 feet in width each side of the center of the vein, 1490 feet of said lode running east from the point of discovery (designated by the location monument). The general course of the lode or vein as near as can be presently determined is east and west. (e) Since the date of said location and prior to the date of this certificate, the undersigned caused location work to be performed upon said mining claim consisting of maps as provided in NRS 617.040.
