

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN by these presents, that the undersigned locator having complied with all of the requirements of the law and local rules and customs has claimed and claim by right of discovery and location a lode mining claim in the Unknown Mining District, County of Eureka, State of Nevada, and hereby certify that:

Corner; thence South 400 feet to the S.E. Corner; thence west 1500 feet to the S. W. Corner, at the point of beginning. The S.W. Corner of this lode claim is situated 4500 feet in a WEST direction and 3600 feet in a NORTH direction from the S.E. Corner, Sec. 20, T.33 N., R.50 E., M. D. B. & M., Eureka County, Nevada.

(d) The undersigned claim is 1500 feet, linear and horizontal measurement, along the course of the vein, together with 200 feet in width each side of the center of the vein, 1480 feet of said lode running east from the point of discovery (designated by the location monument).
